"LPG-Refilled Tin Canister"




- Quality of valve material and composition



Quality And Safe Fuel For Next Generations

Appeal to LGUs and Business Sectors

LGUs:

- Take a strong public position on its support to stop illegal activities in the downstream oil industry sector
- Pass and implement local ordinances that will support the implementation of DOE rules and regulations on petroleum products and facilities
- Enforce the closure of erring petroleum facilities, as recommended by DOE
- Support public awareness program of the DOE on downstream oil industry consumer safety
- Support the immediate passage of pending bill (i.e. LPG Bill)

Business Sector:

- Work towards self-regulation
 - Ensure compliance to national standards
 - Employ international codes of practice (absent of local standards)
 - > Refrain from selling to violators, both potential & persistent
- Coordinate with LGU's re: authority of DOE on industry vs. authority of LGUs on the business
- Enhance IEC campaigns price, quality, quantity, fair & safe trade practices
