Bid Bulletin No. 1 for 17th Public Bidding CY2023

- A. Rebidding for the Procurement for the Supply and Delivery of LED Lighting Products for Local Government Units (LGU) and Public School under "Palit Ilaw" Programme.
 - 1. Clarification:
 - a. Terms of Reference/Technical Specifications
 - V. COMPLETION PERIOD

The supply of LED Lighting Systems must be completed within ninety (90) calendar days upon receipt of the Notice to Proceed (NTP).

VII. INSPECTIONS AND TESTS

The Purchaser may reject any Goods or any parts thereof that do not conform to the specifications and fail any tests and/or inspections of the target beneficiaries. The field test/inspection will be through random sampling method for the operational test of at least 2% of the total quantity of goods delivered.

For the validation of Energy Efficiency Rating, illuminance and power consumption, among others, the Supplier must comply with the requirement of the Implementing Guidelines of the Philippine Energy Labeling Program for Lighting Products of before proceeding with the field delivery.

The Supplier shall immediately rectify or replace such rejected Goods or parts thereof.

- B. Procurement of Services for the Production of Audio-Visual Presentations and other Multimedia Materials, and Concept, Layout, and Printing of Campaign Materials on the Investment Opportunities in the Renewable Energy Sector in the Philippines.
 - Single Largest Completed Project SLCC: The coverage period for SLCC: increased from four (4) years to five (5) years.

 Non-editable digital files submission of completed works is acceptable.
