Resolution No. 443 s. 2023

A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH THE USE OF ALTERNATIVE METHOD OF PROCUREMENT (AMP), FOR THE PROCUREMENT OF SERVICES FOR THE PUBLICATION OF DC2023-10-0030 ENTITLED "GUIDELINES ON ENERGY EFFICIENCY EXCELLENCE AWARD"

WHEREAS, the Bids and Awards Committee (BAC) received a Memorandum dated 14 November 2023 from Director Elisa B. Morales of the Administrative Services (AS), requesting the BAC's approval through the use of Alternative Method of Procurement (AMP)-Section 53.6, for the Procurement of Services for the Publication of DC2023-08-0025 Entitled "Guidelines on the Energy Efficiency Excellence Award" dated 14 November 2023 with a running balance as of 14 October 2023 in the amount of Six Hundred Forty Thousand Nine Hundred Twenty Six Pesos and 40 Centavos Only (Php640,926.40);

WHEREAS, this procurement was included in the Department's CY2023 Annual Procurement Plan approved by the Secretary Raphael P. M. Lotilla;

WHEREAS, Section 48.1, 53 and 53.6 Rule XVI of the 2016 Revised IRR of R.A. 9184 authorized the conduct of Negotiated Procurement under AMP, the pertinent provisions of which are quoted as follows:

"Sec 48.1 Alternative Methods – Subject to the prior approval of the Head of Procuring Entity (HoPE), and whenever justified by the conditions provided by this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained:

"Sec. 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant only in the following cases:

x x x x x x x

Section 53.6. Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services. Where Goods, Infrastructure projects and Consulting Services can be contracted to a particular supplier, contractor or consultant and as determined by the HoPE, for any of the following:

1. *The requirement is for:*

- e. *Media documentation, advertisement, or announcement through television, radio, newspaper, internet, and other communication media. Due to the nature of the*

information to be disseminated, alongside principles of transparency, efficiency and economy, award to more than one (1) supplier maybe made by the Procuring Entity.

WHEREAS, the BAC received three (3) quotations canvassed by the end-user which were endorsed to the BAC-Technical Working Group (TWG) for evaluation, details of which are as follows:



WHEREAS, based on the evaluation of the above-quotations by the DOE-TWG, the result of which was presented to the BAC during its Regular Meeting No. 41 on 16 November 2023, Businessworld Publishing Corp., and Daily Tribune (Concept & Information Group, Inc.) submitted the **Lowest Calculated Responsive Bids** for the required publication in Two (2) newspaper of general circulation and, accordingly, were recommended the contract in its favor;

NOW, THEREFORE, in view of the foregoing, and upon motion duly made by **Ms. IMELDA M. ROXAS**, the proponent of the activity, the BAC has resolved, as hereby it is, **RESOLVED** to:

1. **APPROVE** the BAC-TWG findings and recommendation for the award of contract for the Procurement of Services for the Publication of DC2023-10-0030 Entitled "Guidelines on the Energy Efficiency Excellence Award" dated 14 November 2023 to **Businessworld Publishing Corp.** and **The Daily Tribune (Concept & Information Group, Inc.)** in the amounts of **Twelve Thousand Two Hundred Thirty Pesos and 40 Centavos Only (Php12,230.40)** and **Thirteen Thousand One Hundred Seventy One Pesos and 20 Centavos Only (Php13,171.20)** respectively;
2. **RECOMMEND** to the Head of Procuring Entity, the approval of the award of the above-mentioned contract; and,
3. **FURNISH** the Commission on Audit, for its information and reference, a copy of this Resolution immediately after its approval by the Head of Procuring Entity;


