- 2. The winning bidder shall provide/supply Printer for "free use" to the DOE-VFO, located at 3rd Floor, Escario Building, 731 Escario Street, Capitol Site, Cebu City.
- 3. The bidder shall conform strictly to all the terms and conditions of these Terms of Reference.
- 4. The bidder shall provide regular free on-site maintenance and technical support.
- 5. All printers, inks and toner units delivered to DOE-VFO which had been found defective shall be replaced by the winning bidder within three (3) working days upon receipt of report from DOE-VFO. The

- replacement unit shall be of the same or upgraded specifications as the defective unit.
- 6. The winning bidder shall be responsible for the disposal of empty bottles and cartridges.
- 7. The winning bidder shall pull out the printers until the DOE-VFO has awarded the procurement to the next winning bidder in the next procurement cycle or as requested by the DOE-VFO.
- 8. The winning bidder shall ensure that the Color All-in-one Printers and Monochrome Printers are always in good working condition.
- 9. The winning bidder shall be responsible for the troubleshooting/repair of all printing equipment.
- 10. The winning bidder shall not charge the DOE-VFO on the replacement of parts and repair/troubleshooting of the printers.

Duration and Terms of Payment

- 1. One hundred percent (100%) of the contract price will be released in Thirty (30) working days upon satisfactory completion/acceptance of the end user.
- 2. The winning bidder shall deliver upon receipt of the Approved Purchase Order from the end-user.
