The Energy Investment Coordinating Council (EICC), through the Department of Energy as the lead agency in the implementation of the Executive Order No. 30, is pleased to inform you that your application for the declaration of your project **Pagbilao 650 MW Combined Cycle Gas Turbine Power Plant** has been approved. As such, a corresponding **Certificate of Energy Project of National Significance (CEPNS) for Commercial Phase** has been issued in your favor.

The CEPNS for Commercial Phase carries with it the following rights, and terms and conditions as follows:

- a. Action on the application within 30 working days;
- b. Presumption of prior approval;
- c. Deemed approval if no action is made five (5) days after the lapse of the 30 working day period for processing of the application; and,
- d. Submission of Monthly CEPNS Monitoring Sheet every 10<sup>th</sup> of the succeeding month to the EICC Secretariat detailing the progress of the implementation of the projects with respect to its permitting requirements. (Please see attached CEPNS Monitoring template)

As stated in the Certificate, the DOE, in the exercise of its supervisory power, has the right to amend, alter or revoke the CEPNS for Commercial Phase, in cases of irregularity and violations in the conditions for which the Certificate was issued.
