- Upgrade the 69 kV Transmission Lines and Substations



REQUIRED CERTIFICATES



Under NCIP Administrative Order No. 3 Series of 2012 (Sec. 5 [d] and [e])***

CERTIFICATE OF NON-OVERLAP (CNO)

It refers to the Certificate issued by the NCIP attesting to the fact that the area where the particular plan, program, project or activity will be done does not overlap with, or affect, any ancestral domain.

CERTIFICATE PRECONDITION

It refers to the Certificate issued by the NCIP, signed by the Chairperson, attesting to the grant of Free Prior Informed Consent (FPIC) by the concerned ICCs/IPs after appropriate compliance with the requirements provided for in this Guidelines.

ISSUES/CONCERNS/OBSERVATIONS/



- 1. How will NPC compensate Project Affected Properties, pay individual persons/owners or pay to the elders and decide on the sharing among themselves?
- In case of overlapping jurisdiction between DENR and NCIP, who
 will decide on the required documents? There are ancestral
 domains claimed by NCIP, which are not recorded/documented in
 the DENR maps. They are still classified either as Timberland or
 Public lands.
- 3. Absence of Ancestral Domains Master List or Map.

ISSUES/CONCERNS/OBSERVATIONS



- 4. Tedious Processing of Application.
- 5. No timeline for the processing (and approval) of certificates.

SUGGESTION/REQUESTS



- 1. For NPC's Existing Power Plants/Facilities, waive the requirements under Section 7 of the NCIP Administrative Order No. 3 series of 2012 since these power plants have been in operation without issues raised from the community.
- Sec. 7. "The applicant shall submit a company and project profile which shall include: the nature and purpose of the project; location with an indicative map showing the names of sitios and/or barangays that will be affected; Abstract of proposed project describing the size, pace, reversibility and scope; duration; preliminary assessment of the likely economic, social, cultural and environmental effects, including potential risks and how these will be addressed; Indicative budget; Persons to be involved in implementation; Operational Plan and activities; and the Profile of the applicant.

SUGGESTION/REQUESTS



- 2. For the CNO application, it is requested to dispense the holding of Pre-FBI (Field Based Investigation) and Pre-FPIC (Free and Prior Informed Consent) for existing power plants since there is no issues raised in its operation.
- 3. Waive the requirement for CNO for project sites that have been established by the government as non-IP areas.
- NCIP to have a MASTER LIST OR MAP of all areas covered by Ancestral Domains to expedite approval of CP and CNO applications;

SUGGESTION/REQUESTS



- 5. If established as IP areas, waive the holding of community assemblies. Instead a MOA will be signed among stakeholders.
- NCIP to have a MASTER LIST OR MAP of all areas covered by Ancestral Domain to expedite approval of CP and CNO applications;
- 7. Definite time table for approval of the CNO, CP or other documents required. Request not acted within 30 days upon submission shall be deemed approved.
