We presented a DOE study on what is the best situation for WESM to be introduced in the Visayas. And one of those United Nation study, required an N-1 provisions for the Visayas grid. At that time, it was too expensive to do it, and is still too expensive now. The story of Western Visayas electric cooperatives will continue to suffer from high line rental until all the generators are islanded in Panay. If there is also an oversupply of capacity in Panay as Concepcion coal fired and other incoming plants, it will not also be able to export to Negros. And Negros will again suffer what is happening to Panay. If and when that study is still in the library of the DOE, kindly look back at that recommendation because it will improve and help good WESM facilities not only in the Visayas, but even in the forthcoming Mindanao IMEM.
